Report Summary

Licenses - During **2021** there were **15** liquor licenses issued to existing businesses and **one** liquor license issued to a new business. A listing of licenses by classification and fees paid is found attached to this report.

A total of <u>\$17,450</u> was collected in licensing fees for the various classifications established by ordinance.

Incidents - During **2021** there was **two** incident requiring police intervention or action to the **15** liquor license businesses.

On July 18, 2021, police were dispatched to Candy's Place Bar and Grill for a report of a disturbance involving a large fight. Three people were issued LO Citations for Breach of Peach and one was also charged with Battery of a Peace Officer. The owner of the business contacted police at the time of the incident and signed the LO Citations against all three subjects who were caught. No liquor violations were observed in regard to this incident.

On December 26, 2021, at Eduardo Leamon Cigars, an intoxicated female was asked to leave. The female called 911 when an unknown subject identified himself as a security guard for the establishment and struck her with an unknown object, presumed to be a bottle. No arrest was made as the offender was not identified, nor on the scene. The injured female was the only caller in this matter. The liquor establishment did not call the police. It was noted in the liquor incident report that Further Investigation take place and the Chief of Police also concurred with this recommendation. The Village Attorney was notified and he stated that given the fact that this is a cigar bar and not your typical bar-restaurant liquor license, it may be better to have a counseling session with the ownership rather than a formal hearing process. The Chief & Deputy Chief of Police met with the ownership to have this counseling session, which was documented.
